## Rules of the Dole Baking contest:

1. Competitor must be a Tennessee resident 18 years of age or older to enter.
2. One entry per person.
3. Competitor must be an individual, not a company.
4. Create a fruit dessert that utilizes Dole's line of canned fruit as one of its main ingredients.
5. Visit [www.dole.com/products/canned-fruit](http://www.dole.com/products/canned-fruit) to verify you are using the correct product. Products include:
  - a. Pineapple Slices in 100% Pineapple Juice (8 or 20 oz can)
  - b. Pineapple Slices in Heavy Syrup (8 or 20 oz. can)
  - c. Pineapple Chunks in 100% Pineapple Juice (8 or 20 oz can)
  - d. Pineapple Chunks in Heavy Syrup (8 or 20 oz can)
  - e. Pineapple Tidbits in 100% Pineapple Juice (8 or 20 oz can)
  - f. Crushed Pineapple in 100% Pineapple Juice (8 or 20 oz can)
  - g. Crushed Pineapple in Heavy Syrup (8 or 20 oz can)
  - h. Mandarin Oranges in Light Syrup (11 or 15 oz can)
  - i. Tropical Fruit in Light Syrup and Passion Fruit Nectar (15 oz can)
  - j. Mango Slices in Heavy Syrup (15 oz can)
6. Submitted desserts can feature Dole canned fruit products in breads, cookies, pies, cakes, puddings, or any other dessert-focused dish.
7. Recipe must be original, created, and owned by entrant. Recipe should not have been previously published in any media, including but not limited to on any restaurant menu, in any cookbook, magazine, newsletter, food packaging, on food or recipe websites or entered into a competition. Recipe cannot contain any third party content, including but not limited to any copyrighted material, third party trademarks, and/or names or likeness of any third parties.
8. The recipe **MUST** be **TYPED** on an 8 1/2 x 11 inch sheet of paper. On **REVERSE** side of recipe **TYPE** your name, address, phone number, and e-mail address. Submit three (3) copies of the recipe with your entry form.
9. Recipes should list ingredients with measurements and amounts. Recipes should include step by step preparation and baking instructions. Recipe should include estimated preparation time and total baking time. Be specific.
10. With entry submission, you accept all Contest rules and agree to be bound by the judges' decisions, which will be final. All rights of ownership, including copyright, in all recipe entries are assigned exclusively to Colorado State Fair and Dole Packaged Foods, LLC ("Dole") upon submission into the competition.
11. Each entrant agrees to take any actions (including execution of documents) reasonably requested by Dole to effect, perfect or evidence the forgoing assignment. Each entrant agrees to use of his or her name, likeness, photographs, recipes and/or prize information by Dole for advertising and promotional purposes in any medium, whether now known of hereafter developed, throughout the world and in perpetuity, including but not limited to sharing via

Dole's social channels including Facebook, Twitter, and Pinterest, without compensation. Nothing shall obligate Dole to so use or engage in any of the above advertising or promotion.

12. Containers will not be returned to competitors at the conclusion of the contest.

General Appearance 25%

Originality 25%

Flavor 50%

**Directions for submission:**

Each competitor will receive by email a copy of this information sheet and a Fair pass no later than Wednesday, September 14, 2016.

The Fair pass is good for free parking and entry to the fair for the competitor only. You MUST have pin in hand to receive free parking and free entry.

Fair gates open at 10:00AM on Saturday, September 17, 2016; however, submissions for the competition will be received from 3:00 p.m. to 4:00 p.m. in the Creative Arts Building. NO SUBMISSIONS WILL BE RECEIVED AFTER 4:00 p.m. Please refer to the countdown clock at the check-in station.

Preliminary judging will take place immediately following the 4:00 p.m. submission deadline.

The final round of judging will take place at 4:15PM with a first, second, and third place winners crowned at its conclusion.
